Also, please describe in greater detail how you concluded that you would not need to issue any more shares under the Adjusted Awards plan. Finally, please tell us how your review of Regulation C promulgated under the Securities Act of 1933, as amended and the Compliance and Disclosure Interpretations of the Securities Act led you to the conclusion that you could reallocate how you would distribute shares under the Registration Statement.
