In connection with a Merger transaction which was completed on May 9, 2006, the Series A Common stock was exchanged for two tracking stocks: Series A Liberty Interactive Common Stock (CUSIP 53071M104) and Series A Liberty Capital Common Stock (CUSIP 53071M302). On March 3, 2008, the Issuer completed A reclassification of each share of Series A Liberty Capital Common Stock into one share of Series A Liberty Capital Common Stock and four shares of Series A Liberty Entertainment Common Stock (CUSIP 53071M500). Going forward, the filing parties will Treat each of the tracking stocks as separate classes for purposes of Rule 13d-1.
