On September 23, 2011, the Issuer redeemed each share of its Series A Liberty Capital Common Stock for one share of Liberty Media Corporation's (formerly known as Liberty CapStarz, Inc.) Series A Liberty Capital Common Stock, and each share of its Series A Liberty Starz Common Stock for one share of Liberty Media Corporation's Series A Liberty Starz Common Stock (the "Redemption"). The reported transaction occurred prior to the Redemption.
- (1) The Reporting Person is voluntarily reporting this transaction early on a Form 4, which transaction occurred on July 13, 2011.
- (2) Reflects the reporting person's holdings immediately prior to the Redemption.
- (3) The Reporting Person disclaims beneficial ownership of these shares owned by his spouse.
